



Hunting Agreement Between La Condesa Ranch, Hunter(s), and Guest(s)

By signing this document, I/we (hunters and guests), and acknowledge that I/we have been provided a copy of all terms, conditions, safety protocol, rules, policies, price sheet, liability release, and photo/video release, with this agreement. I/we agree that I/we fully understand and agree to all above and included documents and terms included therein.

I/we hereby also agree to and understand the following:

- To pay deposit in advance per policy, and understand that refunds are only granted if cancellations are made *before* 48 hours prior to scheduled hunt.
- Deposit will apply towards cost of animal(s) taken. If no animal is taken, the daily use fee will be deducted from deposit, and the remaining deposit will be refunded.
- Hunter is responsible for full cost of wounded game even if not found. LCR will send antlers to hunter if found at a later date. (NOTE: every diligent effort will be made by LCR staff and hunter to find wounded animal(s), but as sometimes occurs, animals may not be found despite diligent efforts). All hunts are filmed to help track the direction of wounded game, and any blood found will also aid in search process. Video and blood or other evidence (stomach fluids, flesh particulates, etc.) will also serve to prove if an animal is or is not hit/wounded.
- Hunter is responsible for cost of recovery efforts of any animal which requires it (use of dogs, etc.).
- LCR will clean animals at camp but hunter is responsible for final processing.
- ABSOLUTELY NO PETS allowed by guests/hunters unless required for personal assistance. PLEASE NOTE: if guests have special needs, please let us know in advance so we can provide accommodations if possible. There may be some limitations due to current setup of facilities but we will do our best to accommodate if at all and as much as possible.
- Snake chaps or boots are HIGHLY recommended.
- Hunter(s) must demonstrate accurate and confident shooting skills PRIOR to first hunt. (NOTE: please plan to arrive early enough to shoot at our range before first hunt).
- Hunter/guest who damages ranch property whether by accidental or by intentional means, is fully responsible for replacement or repair charges at the discretion of LCR staff.
